

**PERMOHONAN MENDAPAT STATUS PENDUDUK TETAP (PR) DI JABATAN  
IMIGRESEN MALAYSIA  
APPLICATION FOR PERMANENT RESIDENT (PR) STATUS AT IMMIGRATION  
DEPARTMENT OF MALAYSIA**

**PROSEDUR/PROCEDURES:**

- a) Pemohon perlu mendapat Surat Kelulusan Talent Corporation Malaysia Berhad (TalentCorp).  
*Applicant must obtain a valid Approval Letter from Talent Corporation Malaysia Berhad (TalentCorp).*
- b) Permohonan hanya boleh dilakukan di Ibu Pejabat Imigresen Putrajaya **SAHAJA**.  
*Application can **ONLY** be submitted at Immigration Department HQ in Putrajaya.*
- c) Proses permohonan bagi mendapatkan status PR akan mengambil masa selama **enam (6) bulan** dari tarikh permohonan yang lengkap dihantar ke Jabatan Imigresen. Untuk Sabah dan Sarawak, pemohon perlu berada di sana sekurang-kurangnya lima (5) tahun sebelum dipertimbangkan untuk diberi status PR.  
*Application for PR will be processed within **six (6) months** after a completed application has been submitted to the Immigration Department of Malaysia. For Sabah and Sarawak, applicant must have been residing there for a minimum of five (5) years prior to submitting the PR application.*
- d) Pemohon perlu membuat permohonan dengan datang sendiri ke:

*Applicant's wedding picture and family picture*

**Nota/Notes:**

- i. Pemohon dikehendaki membawa salinan asal semua dokumen semasa membuat permohonan.  
*Applicants are required to bring all the original documents while submitting the application.*
- ii. Semua salinan dokumen perlu disahkan oleh pegawai kerajaan atau Pesuruhjaya Sumpah.  
*Copies of the documents need to be certified by Government Official / Commissioner of Oath.*
- iii. Semua dokumen hendaklah disalin di atas kertas berukuran A4.  
*Photocopy of the documents need to be made on A4 sized paper only.*
- iv. Pihak Imigresen juga berhak meminta pemohon mengemukakan dokumen lain sekiranya perlu.  
*The Immigration Department has the right to ask for additional documents when necessary.*
